Article VIII-Non-Profit/Fiscal Management: WAS CHANGED TO READ AS: This Corporation is organized for any lawful purpose for which corporations may be incorporated in this jurisdiction under the Florida Non-Profit Corporation Act. No part of the net earnings of the organization shall be used to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidates for public office. Notwithstanding any other purposes not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Article IX – Bylaws: WAS CHANGED TO READ AS: The bylaws of the corporation are made, altered or rescinded by consent of a majority of the membership. In order to change the corporation bylaws, the Board of Directors shall arrange for a meeting of the membership specifying the purpose, location and time of the meeting. The Board of Directors shall advise the members of the subject of the meeting at least ten (10) days prior to the scheduled meeting.

Article X – Amendments: WAS CHANGED TO READ AS: These articles of corporation may be amended by an act of the corporation membership. Such amendments to these articles shall require a concurring majority vote of the corporation members present.

Article XI – Dissolution: WAS CHANGED TO READ AS: Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the court of Common Pleas of the county in which the principal office of the organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
