The undersigned, natural person of the age of eighteen years or older, acting as incorporator for the purpose of creating a nonprofit corporation under the laws of the State of Florida in compliance with Chapter 617, F.S., do hereby set forth:

Article I The name of the corporation is **Association for the Restoration of Children**, Inc.

Article II The principal place of business and mailing address of this corporation is:

Article III The purposes for which the corporation is organized are:

a. The initial projects of Association for the Restoration of Children, Incare targeted at Southern Africa, but eventually the focus could be worldwide. The organization will also give financially to other non-profit organizations.
