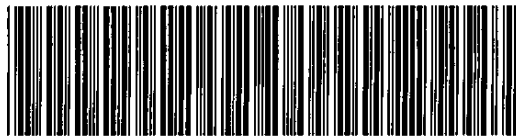

**ARTICLES OF INCORPORATION
OF
OUR ROADS ASSOCIATION OF SADDLE CREEK, INC.**

In compliance with the requirement of Chapter 617, Florida Statutes, the undersigned has this day voluntarily executed for the purpose of forming a corporation not for profit and does hereby certify:

**ARTICLE I
NAME**

The name of the corporation is OUR ROADS ASSOCIATION OF SADDLE CREEK, INC. ("Association").

**ARTICLE II
PRINCIPAL OFFICE**

The principal place of business and the mailing address of the Association shall be:

4830 Maine Avenue
Lakeland, FL 33801

**ARTICLE III
REGISTERED AGENT**

The street address of the initial registered office of the Association is 103 W. Dampier Street, Inverness, FL 34450, and the name of its original registered agent at such address is Shannon J. Laviano.

**ARTICLE IV
DEFINITIONS**

The capitalized terms used in these Articles shall have the same definitions as are given to such terms in the Declaration of Covenants, Conditions, Restrictions, Reservations, Licenses and Easements for Saddle Creek Village recorded in the Public Records of Polk County, Florida ("Declaration") O.R. Book 1922, Page 304, together with O.R. Book 2066, Page 1759, O.R. Book 4446, Page 1762, O.R. Book 5455, Page 3, and O.R. Book 5455, Page 11, of the Public Records of Polk County, Florida. The Declaration is by this reference incorporated into and made part of these Articles. The declaration will encumber the real property ("Property") described in the Declaration. The Declaration may be amended from time to time in accordance with its terms.

ARTICLE V
PURPOSE AND POWERS OF THE ASSOCIATION

The Association does not contemplate pecuniary gain or profit to its members. The Association is formed to provide for the improvement, maintenance, preservation and control of the Property and to promote recreation, health, safety and welfare of the Owners. The Association, may unless otherwise provided by the law:

- a. exercise all the powers and privileges and perform all the duties and obligations of the Association as set forth in the Declaration, as it may be amended from time to time, applicable to the Property;
- b. affix, levy, collect and enforce payment by any lawful means of all liens, charges, fines or assessments under the terms of the Declaration and Bylaws, pay all expenses in connection therewith and pay all office and other expenses incident to the conduct of the business of the Association, including all licenses, taxes or governmental charges levied or imposed against the property of the Association, and including expenses for the maintenance, operation, and repair of the surface water or storm water management system or to discharge any duty or obligation under any governmental permit;
- c. acquire (by gift, purchase or otherwise), own, hold, improve, build upon, operate, maintain, convey, sell, lease, transfer, dedicate for public use or otherwise dispose of real or personal property in connection with the affairs of the Association;
- d. borrow money and mortgage, pledge, convey by deed of trust, or hypothecate any or all of its real or personal property as security for money borrowed or debts incurred;
- e. dedicate, sell or transfer all or any part of the Common Property to any municipality, public agency, authority or utility for the purpose of providing and maintaining utility or cable service to the Property;
- f. merge or consolidate with other nonprofit corporations organized for the same or substantially similar purposes as the Association;
- g. annex additional property and Common Property provided that any such annexation shall be in accordance with the terms of the Declaration;
- h. waive minor violations (as determined by the Board of Directors) of any one or more of the provisions of the Declaration;

- i. operate, maintain and manage the surface water or storm water management system(s) or other Association facilities or subdivision improvements in a manner consistent with the Polk County permit requirements and applicable rules, or other governmental permits or laws and regulations and shall assist in the enforcement of the Declaration of Covenants and Restrictions which relate to the surface water or storm water management system or any other governmental permit or approval;
- j. levy and collect adequate assessments against members of the Association for the costs of maintenance and operation of the surface water or storm water management system; and
- k. have and exercise any and all powers, rights and privileges that a corporation organized under the laws of Florida applicable to corporations not for profit may now or hereafter exercise.

ARTICLE VI **MEMBERSHIP**

Every person or entity who is a record owner of a fee or undivided fee interest in any Lot which is subject by covenants of record to assessments by the Association, including contract sellers, but excluding persons holding title merely as security for performance of an obligation, shall be a member of the Association. Membership shall be appurtenant to and may not be separated from ownership of a Lot which is subject to assessment by the Association.

ARTICLE VII **VOTING RIGHTS**

- a. The Association shall have one (1) class of voting membership as follows:

Class A. Class A members shall be all owners of Lots, as provided for herein and in the Declaration. Class A members shall be entitled to one (1) vote for each Lot in which they hold an ownership interest. When more than one person or entity holds an ownership interest, each such person or entity shall be a member, but the single vote of such members with respect to the Lot owned by them shall be exercised as they, among themselves, determine. However, in no event shall more than one (1) Class A vote be cast with respect to any Lot which is owned by more than one person or entity.

ARTICLE VIII
BOARD OF DIRECTORS

The affairs of the Association shall be managed by a Board of Directors who need not be members. The initial number of Directors shall be three (3). At the first annual meeting and at each subsequent annual meeting, the members shall elect the Directors for a term of one year or until their successors assume the office. The names and addresses of the persons who are to act in the capacity of directors until the selection of their successors are:

The number of members of the Board and the method of the election of the directors shall be stated in the By-Laws, which may be amended from time to time.

ARTICLE IX
OFFICERS

The names of the officers who are to serve until the selection of their successors are:

President	Mark LaFon
Treasurer	Mark LaFon
Secretary	Pete Nelson

The method of election, duties for each officer, and terms of office for each officer shall be stated in the By-Laws.

ARTICLE X
DISSOLUTION

The Association may be dissolved with the assent of not less than sixty-seven percent (67%) of the voting interests. Upon dissolution of the Association, other than incident to a merger or consolidation, the asset of the Association shall be dedicated to an appropriate public agency to be used for purposes similar to those for which the Association was created. In the event that acceptance of the dedication is refused, the assets shall be granted, conveyed and assigned to any nonprofit corporation, association, trust or other organization devoted to similar purposes. No such disposition of Association assets shall be effective to divest or diminish any right or title of any member

vested in the member under the Declaration, unless made in accordance with the Declaration.

In the event of termination, dissolution or final liquidation of the Association, the responsibility for the operation and maintenance of the surface water or storm water management system must be transferred to and accepted by an entity which would comply with applicable statutes or regulations and be approved by the appropriate water management district prior to such termination, dissolution or liquidation.

ARTICLE XI **AMENDMENT**

The Association reserves the right to amend these Articles of Incorporation in accordance with its By-Laws. The initial By-Laws shall be adopted by the Board of Directors who shall have the power to alter, amend or repeal the By-Laws or adopt new By-Laws.

ARTICLE XII **TERM**

The term of the Association shall be perpetual or until such a time as the not for profit corporation is dissolved under Article X.

ARTICLE XIII **INDEMNIFICATION**

Every director and every officer of the Association serving the Association at its request, shall be indemnified by the Association against all claims, damages, expenses and liabilities, including attorney fees, reasonably incurred by or imposed on the person in connection with any proceeding or any settlement of any proceeding to which the officer or director may be a party or in which the officer or director may become involved by reason of being, or having been, a director or officer of the Association, or by reason of having served the Association at its request, whether or not he or she continues to serve as a director or officer or member serving Association at the time the claims, damages, expenses or liabilities are incurred, except when the director, officer or member serving Association is adjudged guilty of willful misfeasance or malfeasance in the performance of his or her duties; provided that in the event of a settlement before entry of judgment, the indemnification shall apply only when the board of directors approve the settlement and reimbursement as being in the best interest of Association. This right of indemnification shall be in addition to and not exclusive of all other rights to which the director, officer or member serving Association may be entitled.


