Attachment to Articles of Amendment of Tax Aid America, Inc.

Article III shall be amended to read as follows:

Paragraph 1 shall be amended to read as follows:

The purposes for which the corporation is organized are: This Corporation shall be a nonprofit corporation. This Corporation is organized exclusively for social welfare purposes within the meaning of section 501 (c)(4) of the Internal Revenue Code. The corporation's specific purpose is to provide relief to low-income tax payers and Spanish-speaking taxpayers by assisting them with IRS conflicts.

Paragraph 2 shall be amended to read as follows:

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (4) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located exclusively for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.

Paragraph 5 shall be amended to read as follows:

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c) (4) of the Internal Revenue Code. The property of this corporation is irrevocably dedicated to social welfare purposes and no part of the net income of assets of this corporation shall ever inure to the benefit of any director or officer thereof or to the benefit of any private person.

Paragraph 3 should be removed.
