

ARTICLES OF INCORPORATION FOR

Saint Lucie Cricket & Sport Association, Inc.

ADMENDMENT TO ARTICLE III: PURPOSES

CORPORATE PURPOSES: The purposes for which this corporation is formed are exclusively, <u>charitable</u> and educational and consist of the following:

- 1. This corporation is formed exclusively for <u>charitable</u> and <u>educational</u> purposes within the meaning of <u>section 501(c)(3)</u> of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law."
- 2. To do any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishment, fostering, or attaining of the foregoing purposes, either directly or indirectly, and either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature, such as corporations, firms, association, trusts, institution, foundations, or governmental bureaus, departments or agencies. Therefore and in accordance with section 501(c)(3) of the Internal Revenue Code of 1986, among other goals, a primary purpose of the organization is to support both the educational and healthy development of at-risk youths, through strengthening and expanding our weekend sports program, in low-income/at -risk communities, in the St. Lucie county and surrounding areas.
- 3. All of the foregoing purposes shall be exercised exclusively for charitable and educational purposes in such a manner that the Corporation will qualify as an exempt organization under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

501(c)(3) LIMITATIONS

- 1. **EXCLUSIVITY:** The Corporation is organized exclusively for charitable and educational purposes.
- 2. NO PRIVATE INUREMENT: No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal Income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (B) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- 3. **LOBBYING AND POLITICAL CAMPAIGNS**: No substantial part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.
- 4. **DISSOLUTION:** Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the County in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for
