

The name of this corporation is GOLF VILLAS INVESTORS, INC. The mailing address/principal office of the corporation is: 1929 Turnbull Lakes Drive, New Smyrna Beach, Florida 32168.

#### Article II - Duration

This corporation shall have perpetual existence.

# Article III - Purposes

# Article IV - Capital Stock

The maximum number of shares of stock which this corporation is authorized to have outstanding at any time shall be one hundred thousand (100,000) shares of common voting stock with a par value of ten cents (\$.10) per share. All stock issue shall be fully paid.

# Article V - Preemptive Rights
