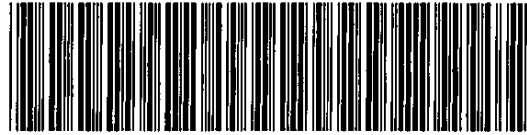





ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I **NAME**

Effective Date 06/01/2007

The name of the corporation will be:

The F of X New Music, Inc.

ARTICLE II **PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

5984 SW 83 Street, South Miami, FL 33143

ARTICLE III **PURPOSE**

The purpose for which the corporation is organized is:

The corporation is organized exclusively for literary, artistic, musical, educational and scientific charitable purposes and for the advancement of education, music and science, including, for such purposes, the bringing of newly-emerging musical and performing art forms to the public through live performances, all as limited to those exempt purposes specified in Section 501(c)(3) of the Internal Revenue Code.

ARTICLE IV **EARNINGS**

The earnings, if any, of the corporation shall be restricted as follows in compliance with Section 501(c)(3) of the Internal Revenue Code:

No part of the net earnings of the corporation, if any, shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payment sand distributions in furtherance of the purposes set forth in Article III hereof.

ARTICLE V **ASSETS**

The assets, if any, of the corporation shall be restricted as follows in compliance with Section 501(c)(3) of the Internal Revenue Code:

All assets, if any, of the corporation, shall be permanently dedicated to the exempt purposes as set forth in Article IV hereof. Upon the dissolution of the corporation, the assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal, state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine.




