Fight OUT Loud, Inc.**

Pursuant to Florida Statutes, Chapter 617.0202 (Not-for-Profit)

**Article I: Name**

The name of the not-for-profit corporation shall be Fight OUT Loud, Inc.

**Article II: Principal Office**

The principal place of business and mailing of this corporation shall be Fight OUT Loud, Inc., 5280 N.E. 1 Terrace, Oakland Park, FL 33334.

**Article III: Purpose**

Fight OUT Loud, Inc. is organized exclusively for charitable, religious, educational, scientific, or literary purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of the United States Government, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under 501(c)(3) of the Internal Revenue Code of the United States Government or the corresponding section of any future United States Internal Revenue law. Specifically, Fight OUT Loud, Inc. will assist in eradicating discrimination against gay, lesbian, bisexual, and transgendered individuals.

**Article IV: Manner of Elections**

The directors and officers will be elected or appointed at each annual meeting, to take place during the month of June. The method of election of the directors and officers is stated in the bylaws.

**Article V: Initial Directors and Officers**

1. Director and President: Jerry Waymon Hudson, 5280 NE 1 Terrace, Oakland Park, FL 33334.
2. Director and Vice President: Anthony S. Niedwiecki, 5280 NE 1 Terrace, Oakland Park, FL 33334.
3. Director: Carlyn Hudson Weaver, 17703 Coatbridge Place, Olney, MD 20832.

**Article VI: Initial Registered Agent**

Jerry Waymon Hudson, 5280 NE 1 Terrace, Oakland Park, FL 33334.

**Article VII: Incorporator**

Anthony S. Niedwiecki, 5280 NE 1 Terrace, Oakland Park, FL 33334.

**Article VIII: Activities of Corporation**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, any of its members, trustees, officers or other private persons, except that the corporation shall be authorized to pay reasonable compensation

for services rendered and to make payments and distributions in furtherance of the exempt purposes.


No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**Article IX: Dissolution**

Upon the winding up and dissolution of Fight OUT Loud, Inc., after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of the United States Government, or the corresponding section of any future federal tax code.

Having been named as register agent to accept service of process for the above stated not-for-profit corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
