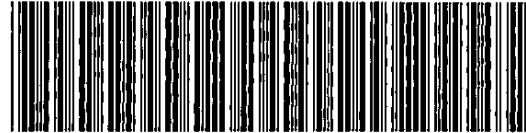

**I**

The Name of the corporation shall be Fisher Immediate Family Homeowners Association, Inc.

**II**

The duration of the corporation shall be perpetual.

**III**

The purpose for which the corporation is organized is to provide for the preservation of the values, amenities, attractiveness and desirability of real property known as Fisher Immediate Family Subdivision located in Gadsden County Florida.

IX


Every person that is a record owner of a lot in Fisher Immediate Family Subdivision of the Association. Membership is appurtenant to and may not be separated from ownership of any lot.
