ARTICLES OF INCORPORATION OF

THE CENTRAL FLORIDA CHAPTER OF THE STUDEBAKER DRIVERS CLUB, INC.

The undersigned hereby associate themselves for the purpose of forming a corporation not-for-profit under Chapter 617, Florida Statutes, as amended, and certify as follows:

ARTICLE I NAME

1.1. The name of the corporation shall be The Central Florida Chapter of the Studebaker Drivers Club, Inc., hereinafter referred to as the "Club".

ARTICLE II INITIAL REGISTERED OFFICE AND AGENT

2.1 The street address of the initial principal and registered office of this corporation is the following:

ARTICLE III PURPOSE



ARTICLE V POWERS

5.1. <u>Powers</u>: The Club shall have all of the common law and statutory powers of a corporation not-for-profit.

ARTICLE VI MEMBERS

- 6.1. <u>Members</u>: The members of the Club shall consist of all applicants approved by the Board of Directors.
 - 6.2. <u>Voting</u>: Each member shall be entitled to one vote as a member of the Club.

ARTICLE VII DIRECTORS/OFFICERS

7.1 Officers: The affairs of the Club shall be administered by Officers designated in the Bylaws of the Club. The Officers shall be elected by the Board of Directors at its first meeting following the Annual Meeting of the Club and shall serve at the pleasure of the Board of Directors. The method of election of the Directors is designated in the Bylaws of the Club. The initial Directors and Officers are:

ARTICLE VIII INDEMNIFICATION

8.1. Every Director and every Officer of the Club shall be indemnified by the Club against all expenses and liabilities, including legal fees, reasonably incurred by, or imposed upon him in connection with any proceeding or the settlement of any proceeding to which he may be a party, or in which he may become involved by reason of his being or having been a Director or Officer at the time such expenses are incurred, except when the Director of Officer is adjudged guilty of willful and wanton malfeasance or malfeasance in the performance of his duties, provided that in the event of a settlement, the indemnification shall be in addition to and not exclusive of all other rights to which such Director or Officer may be entitled.

ARTICLE XI BYLAWS

9.1. <u>Bylaws</u>: The Bylaws of the Club shall be adopted by the Board of Directors and may be altered, amended or rescinded in the manner provided by the Bylaws.

ARTICLE X DISSOLUTION

10.1 <u>Dissolution</u>: Upon the dissolution of the corporation, assets shall be distributed for one or more purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding Section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and intended exclusively for such purposes.

ARTICLE XI TERM

11.1. The term of the Club shall be perpetual.
