ARTICLES OF INCORPORATION FOR ALLIANCE GOSPEL TABERNACLE, INC.

The undersigned incorporators, for the purpose of forming a Florida not-for-profit corporation, hereby adopt the following Articles of Incorporation.

Article I

The name of the corporation is: ALLIANCE GOSPEL TABERNACLE, INC.

Article II

The principal place of business of the corporation is 7118 River Run Road, New Port Riches Florida 34655, and the mailing address of the corporation is 5401 Tughill Drive, Tampa, Florida 33624.

Article III

The purpose for which this corporation is organized is:

Said corporation is organized exclusively for religious purposes under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code; to promote the cause of the Christian religion; and to promulgate the doctrines and teachings of The Christian and Missionary Alliance, a corporation organized under the laws of the State of Colorado, with which this corporation is affiliated and connected as a subordinate body, and subject to its purposes, usages, doctrines, and teachings.
