ARTICLES OF INCORPORATION
FOR
ALLIANCE GOSPEL TABERNACLE, INC.

The undersigned incorporators, for the purpose of forming a Florida not-for-profit corporation, hereby adopt the following Articles of Incorporation.

Article I

The name of the corporation is: ALLIANCE GOSPEL TABERNACLE, INC.

Article II

The principal place of business of the corporation is 7118 River Run Road, New Port Richey, Florida 34655, and the mailing address of the corporation is 5401 Tughill Drive, Tampa, Florida 33624.

Article III

The purpose for which this corporation is organized is:

Said corporation is organized exclusively for religious purposes under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code; to promote the cause of the Christian religion; and to promulgate the doctrines and teachings of The Christian and Missionary Alliance, a corporation organized under the laws of the State of Colorado, with which this corporation is affiliated and connected as a subordinate body, and subject to its purposes, usages, doctrines, and teachings.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this article.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IV

Upon the dissolution of the corporation, its assets shall be distributed to The Christian and Missionary Alliance, a corporation organized under the laws of the State of Colorado, or for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located,
