

### ARTICLES OF INCORPORATION

The programs will consist of Economic Development Programs, but shall not be limited to: Homelessness, Health Care, Computer Technology, Child Care, At Risk Youth Tutorial, Land Acquisition, Housing, Job Training and Placement, Mentorship, Counseling, HIV and Sexually Transmitted Disease Awareness, Aftercare Program, Life Changing Seminars, Outreach Advocacy Programs for Students, Literacy, Teenage Pregnancy and Maternal Child Health Services, Early Child Development Workshops for Teens, Drowning Prevention Awareness, Assist with Foster Care Kids, Youth Academic and Employment Training, Gang Awareness, Gun Violence Education, Substance Abuse Awareness and Prevention, Food for Families, Family Planning, Homosexually Oriented Peer Empowerment Support, Grief and Loss Collaborative and Family Therapy Solutions.

**THREE**: The duration of this Corporation shall be perpetual, no stock and have no members.
