ARTICLES OF INCORPORATION
LAUREL GROVE CEMETERY ASSOCIATION, INC.

ARTICLE I – NAME

The name of the corporation shall be, **LAUREL GROVE CEMETERY ASSOCIATION, INC.**

ARTICLE II – PRINCIPAL LOCATION

The **LAUREL GROVE CEMETERY ASSOCIATION, INC.** is a not for profit corporation located in County of Alachua, in State of Florida. The mailing address of the corporation is Post Office Box 130 Waldo, Florida 32694 and the principal location address is 15340 NE 147th Avenue, Waldo, Florida 32694. The land on which the Laurel Grove Cemetery is situated is described in the records of the Alachua County Property Appraiser as “Idella Kinard K/A Kennard S/D DB S/368-369 Bk 12 & Blk 10 per OR 1756/1874” Section 21-08-24 - Account number 17485-012-000

ARTICLE III – PURPOSE

The purpose for which the corporation is organized is to manage the affairs of the Laurel Grove Cemetery pursuant to the laws of the State of Florida and the bylaws of the corporation.

ARTICLE IV – DIRECTORS, OFFICERS AND MANNER OF ELECTION

The directors and officers shall be elected pursuant to the provisions of the bylaws.

ARTICLE V – EARNINGS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers or other private person, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III – PURPOSE hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of

statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE VI - DISSOLUTION

The dissolution of the corporation shall be as defined in the bylaws and in accordance with the laws of the State of Florida and the Internal Revenue Code.

If the corporation qualifies for any tax exemption under the Internal Revenue Code, upon the dissolution of the corporation, the assets shall be distributed pursuant to the governing Internal Revenue Code and/or classification, or the corresponding section of any future federal tax code. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine.

ARTICLE VII - INITIAL REGISTERED AGENT AND STREET ADDRESS

The name and Florida street address of the initial registered agent is Fred Donaldson, 14058 NE 138th Street, Waldo, Florida 32694, and the mailing address is Post Office Box 130, Waldo, Florida, 32694.
