ARTICLES OF INCORPORATION OF CYPRESS POND ESTATES HOMEOWNERS' ASSOCIATION, INC.

The undersigned incorporator, a resident of the State of Florida of the age of majority, hereby makes, subscribes, acknowledges and files with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation not for profit in accordance with the laws of the State of Florida.

ARTICLE I Name and Address

The name of this corporation is CYPRESS POND ESTATES HOMEOWNERS' ASSOCIATION, INC., hereafter sometimes called the "Association." The principal office and mailing address of this corporation shall be 2307 9th Street E., Bradenton, Florida 34208.

ARTICLE II Purpose and Powers of the Association

This Association does not contemplate pecuniary gain or profit to the members thereof. This Association is formed specifically to promote the health, safety and general welfare of the residents within all or any portion of CYPRESS POND ESTATES, a single-family subdivision lying and being in Manatee County, Florida, (hereinafter "CYPRESS POND ESTATES"). Every person or legal entity who holds legal title of record to a present fee simple interest in any residential lot being a part of CYPRESS POND ESTATES, including contract sellers but excluding persons holding title merely as security for performance of an obligation, shall be a member of this Association. for each such lot owned by the lot owner. Membership shall be appurtenant to and may not be separated from ownership of any lot that is subject to assessment by the Association.
