Article VII, Section 1 is amended to read as follows: Section 1. This Association's affairs are managed by a Board of
Directors initially composed of three (3) Directors. The number of Directors from time to time may be changed by
amendment to this Association's By-Laws, but until such time as it is amended, at all times it must be an odd number of
three (3) or more but not to exceed five (5). The initial Directors named below shall serve until this Association's first annual
meeting. The term of office for all Directors is one (1) year but shall expire at the conclusion of the election at the next
annual meeting, even if the next annual meeting is held less or more than one (1) year following the date of the prior year's
annual meeting. Before any such annual meeting, all vacancies occurring on the Board of Directors, if any, will be filled by
majority vote of the remaining Directors, even if less than a quorum. Any Director may succeed himself or herself in office.
All Directors will be elected by ballot. Each member may cast as many votes for each vacancy as such member has; and the
person receiving the largest number of votes cast for each vacancy is elected. Cumulative voting is not permitted. Directors
must be Association members.
