Article of Incorporation of the undersigned, a majority of whom are citizens of The United States, desiring to form a Non-Profit Corporation under the Non-Profit law of The State of Florida, do hereby certify:

**Article I**

The name of the Corporation shall be The Indian River Green Team, Inc.

**Article II**

The place in this state where the principal office of the Corporation is to be in the City of Vero Beach, the county of Indian River and the state of Florida

**Article III**

Said Corporation is organized exclusively for charitable, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501( c ) (3) of the Internal Revenue Code, or the corresponding section of any future tax code.

Our main purpose is to make Indian River County the "Greenest" county in the state. Through education and raising awareness we can help our citizens focus on certain environmental concerns that face our county, our state, our region, our country and our world. We wish to gather in a public forum at least once a month to discuss areas of concern and formulate a plan to promote positive change in our community.

Membership will be available to any and all that apply and will individually cost \$25 annually. This will make ALL our information available to our members.

Our method will start small on an individual level and then grow to encompass neighborhoods, schools, clubs, business and municipalities and whoever else is willing to incorporate Green Living practices in their own lives. We want to guide, assist and ultimately empower our citizens, both

young and old, to become more aware of our resources and to use them with respect to the global community. We will offer a large array of practices, companies, programs and ideas that will offer the tools needed to facilitate a mindset of living as a global community.

#### **Article V**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and be empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in Article Third hereof. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

#### **Article VI**

The Initial Registered Agent shall be: Nancy B. Wood of 590 26th Avenue in Vero Beach, Florida 32962

#### **Article VII**

Upon the dissolution of the corporation, assets will be used to purchase trees to distribute to our community for one or more exempt purposes within the meaning of section 501 ( c ) (3) of the Internal Revenue Code, or the

corresponding section of any future tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such asset not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court will determine, which are organized and operated exclusively for such purposes.
