
The Pastor/ director of Assembly Of God New Life Hispanic ,Inc is also
The President of Directors, independent of election. The process of election will in the
Following criteria:

- a) By secret voting by lists in a ballot box when there is more than one candidate to complete to the elective functions.
- b) By acclamation when there is only one candidate for the function.
- c) The Board of Directors bureaucratic functions, as a Secretary & Treasury Office will be completed in the following way:
 - 1) Because they are bureaucratic functions they require qualification and available time for the performance of the referred functions:
The candidates will be able to be able to be appointed by the Pastor/Director and by the Local Ministry of Assembly Of God New Life Hispanic , Inc and ratified by acclamation, except if a verified reason prevents it.
 - 2) More than one candidate will also be able to be appointed and voted
By secret voting by lists in a ballot box.
 - 3) After chosen, the new members of the Board of Directors will be presented to the General Assembly by Pastor Director wich will give immediate possession to exercise his mandate by one, year, being finalized the re-election of the same.
 - 4) In case of vacancy on the Board of Directors, the filling of each vacancy will be done by accumulating the functions of the other Directors, obeying the ordered distribution of who will able to do so until the end of the mandate, or intead, the functions can be filled by other people appointed by the Pastor Directors and by the Assembly OF God New Life Hispanaic, inc. Local Ministry.
 - 5) The people who are ineligible for any functions in the Board of Directors of the Assembly Of God New Life Hispanic, Inc. :
 - a) The ones that fall in which do not correspond to the pre-requisites that are mentioned & that its respective lines
 - b) The one s that are absent on voting day
 - c) The absent automatically is ineligible justified for the absence.
