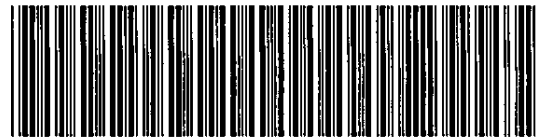

ARTICLES OF INCORPORATION**

ARTICLE I - NAME

The name of the corporation shall be **All Day Athletics, Inc.** ~~(hereinafter "ADA")~~.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of ADA shall be:

ARTICLE III - PURPOSE

ADA is a nonprofit organization organized to further the skill development of amateur athletes, to foster competitive basketball skills through participation in national amateur sports competition, and assist in the education and development of amateur athletes within the meaning of section 501(c)(3), Internal Revenue Code, or the corresponding section of any future federal tax code.

ADA will receive, administer and utilize funds in furtherance of this purpose and, if necessary to carry out its mission, ADA may (a) hold any property, or any undivided interest in property, without limitation as to amount or value; (b) dispose of any such property and to invest, reinvest, or deal with the principal or the income in such manner as, in the judgment of the executive board, will best promote the purposes of ADA within the limitations of section 501(c)(3), Internal Revenue Code, or the corresponding section of any future federal tax code.

No part of the net earnings of ADA shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that ADA shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of ADA's organizational purpose. No substantial part of the activities of ADA shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and ADA shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these Articles, ADA shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3), Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2), Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV - MANNER OF ELECTION

Officers and Directors shall be appointed in accordance with the bylaws of ADA.

ARTICLE V - DISSOLUTION

Upon dissolution of ADA, all assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3), Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of ADA is then located, exclusively for such purposes or to such organization(s) as said court shall determine, which are organized and operated exclusively for such purposes.


