**ARTICLES OF INCORPORATION
OF
UNITED STATES AMATEUR GOLF TOURNAMENT ASSOCIATIONS, INC.**

In compliance with the requirements of F.S. Chapter 617, the undersigned hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a not-for profit business corporation.

ARTICLE I

The name of the Corporation is: United States Amateur Golf Tournament Association, Inc.

ARTICLE II

The street address of the principal office of the Corporation is: 158 Annandale Drive East, Jacksonville, Florida 32225.

ARTICLE III

The purpose of the corporation is to provide the opportunity for sports players to participate in and experience amateur tournaments for sports of all skill levels and to raise funds for charitable organizations, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE V

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a

Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE VI

The initial street address of the Corporation's registered office is: 158 Annandale Drive East, Jacksonville, Florida, 32225. The initial registered agent for the Corporation at that address is: Deborah Thode.

ARTICLE VII

The initial board of directors shall consist of six members. The removal or appointment of board members shall be written in the bylaws. The names and addresses of the persons who will serve on the initial board of directors are:






