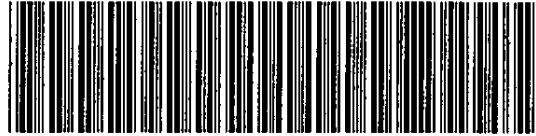

**NAME**

**The name of this corporation shall be MURRAY DANCE BOOSTER ASSOCIATION INCORPORATED.**

**II**

**PRINCIPAL OFFICE**

**The place where the principal office of this corporation is to be located is MURRAY MIDDLE SCHOOL at 150 NORTH HOLMES BOULEVARD, ST. AUGUSTINE FLORIDA 32084.**

**III**

**PURPOSE**

- A. The specific and primary purposes for which this corporation is formed are to assist for charitable purposes, the Dance Department of Murray Middle School.**
- B. This organization is a nonprofit public benefit corporation and is not organized for the private gain of any person. To this end the corporation shall at all times be operated exclusively for charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding section of any future federal tax code.**

No Director shall have any right, title, or interest in or to any property of the corporation. The Directors shall be elected by simple majority vote.**

**DISSOLUTION**


