#### ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida Not for Profit Corporation Act, pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation.

#### ARTICLE I: NAME
