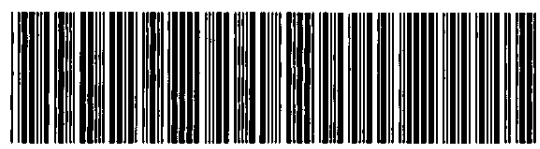

Narrative:

Our corporation was formed purely for scientific purposes. Specifically, we are researching the existence of a bi-pedal hominid known as Sasquatch or Bigfoot. Through this research, we plan to accumulate data to prove the existence of this hominid (Hominid - any of a family of primate mammals that comprise all living humans, extinct ancestral, and related forms). All our efforts will be toward the advancement of research for this species, and to eventually describe it for the scientific community.

Stocking Hominid Research, Inc. (SHR) is comprised of three officers with a combined total of 75 years of experience in studying these hominids. We have worked for years investigating sightings and researching areas of sightings. We have been consulted on this subject by organizations such as Animal Planet, various radio shows, producers, and publishers.

The corporation will be run by the Owner/President/Treasurer, Diane Lee Stocking, Vice President, Ron Schaffner, and Secretary, David Sidoti. Diane Stocking's activities will include field research and data collection, as will all other officers, the filing of documentation, bookkeeping, records keeping, accounts, and the filing of local, state, and federal forms. Ron Shaffner's main duties will be the solicitation of donations to fund the research. David Sidoti's responsibilities will include all filing of documentation, and communications, as well as any and all documentation to procure any permits for research in any areas in the United States and Canada. All papers or articles written for scientific review will be a joint effort of all officers.

Absolutely no fees will be charged to investigate or research a sighting turned in to the corporation from any source. Any persons willing to contact the corporation for help will not be turned down with the exception to the following:

1. We will not investigate anything pertaining to time travel or inter-dimensional travel.
2. Possible perpetrated hoaxes will be looked into at the discretion of the officers.
3. We will reserve the right not to investigate and research any occurrence that we feel does not pertain to a flesh and blood hominid.

The Corporation will be accessible to anyone through the phone numbers and email addresses of the officers; as well as the Stocking Hominid Research, Inc. web site, www.StockingHominidR.com. The officers are well known to independent Sasquatch/Bigfoot researchers. Word-of-mouth references will succeed in furthering our corporation's client/sightings database.

Any offices, field research structures, equipment, vehicles, and other tangible property purchased with Stocking Hominid Research, Inc. funds will be owned by the corporation. All field notes, photos, videos, data, vocalizations, castings, impressions, scientific papers, scientific reviews, and written or visual documentation obtained, and theories of the officers will be the copywrite of Diane

Lee Stocking, Ron Schaffner, and David Sidoti.

The officers will receive a compensation of \$40,000.00 (US dollars) yearly each if, and only if, the funds are available. This compensation will be for the time, effort, and energies freely given for the advancement of hominid research. This amount can be adjusted (higher or lower) on a monthly basis by a joint approval of the officers.

Our corporation will be based in the state of Florida, at 421 Mendel Lane, Titusville, FL 32796. The location of our base of operations could change in the future. At that time, the proper documents will be filed to reflect the change. We will travel to any state, province, or country to research and study any occurrences that might further the advancement of hominid research.

There will be one formal meeting per year for the corporation. Informal meetings will be held to discuss research, locations, equipment, etc. at any time that one or more officers needs to discuss anything pertaining to the corporation with the other officers. Due to the distances involved with the residences of the officers, all meetings will be via e-mail, cell phone, or the USPS. It has been agreed by all officers that electronic signatures will be acceptable if attached to an electronic document.

Funding for Stocking Hominid Research, Inc. will be solely based on donations freely given by any individual, company, or organization.

Our research will involve spending weeks at a time in remote wilderness areas. The research will involve setting up wireless remote cameras and monitors, highly sensitive motion cameras, thermal imaging cameras, and "Bionic Ears" sound monitoring and recording equipment. Equipment for the research will vary from listening and video/sound recording to camping equipment and all terrain vehicles.

To say the least, we are passionately committed to our research. We expect to eventually see great results from our efforts.
