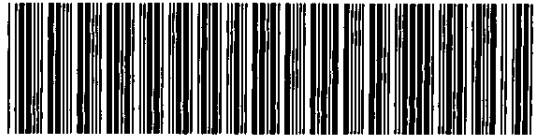

**ARTICLE I**

**NAME**

The name of this corporation is

Dance Arts Centre, Inc.

**ARTICLE II**

**PRICIPAL OFFICE**

The principal place of business and mailing address for this corporation shall be:

3240 W. New Haven Ave.

Melbourne, FL 32904

**ARTICLE III**

**PURPOSE**

This corporation is organized for the purpose of:

1. The Corporation is a non-profit corporation devoted to quality dance training, providing a learning environment for dancers of various levels and styles.
2. No part of the earnings of the Corporation shall inure the benefit of, or be distributable to its directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles of Incorporation.
3. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or (c) by a non-profit corporation organized under the laws of the State of Florida pursuant to the provisions of Chapter 617, Florida Statutes.

**ARTICLE IV**  
**DISSOLUTION**

In the event of the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purposes. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.

**ARTICLE V**  
**MEMBERS AND DIRECTORS**

The qualifications of members and directors and the manner of admission of members together with the manner of election or appointment of directors shall be regulated by the bylaws.

**ARTICLE VI**  
**INITIAL REGISTERED OFFICE AND AGENT**

The street address of the initial registered office of this corporation is 3240 W. New Haven Ave., Melbourne, FL 32904 and the name of the initial registered agent is Sarah Balda.

**ARTICLE VII**  
**INITIAL BOARD OF DIRECTORS**

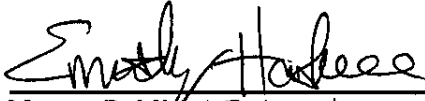
