## PLAN OF DISTRIBUTION OF ASSETS of GRAND PANAMA BEACH RESORT OFFICE CONDOMINIUM ASSOCIATION, INC.

THIS PLAN OF DISTRIBUTION OF ASSETS (this "Plan") is intended to provide for the distribution of the assets of Grand Panama Beach Resort Office Condominium Association, Inc., a Florida not for profit corporation (the "Association"), upon the dissolution of the Association. The Association is being dissolved under Section 617.1402 et seq. and Section 718.117, Florida Statutes, in connection with the termination of the Declaration of Condominium for Grand Panama Beach Resort Office Condominium, which was recorded on June 29, 2007, at Official Records Book 2942, Page 234 of the Public Records of Bay County, Florida (the "Public Records"), and amended by documents recorded on February 2, 2012, at Official Records Book 3383, Page 989 and Official Records Book 3383, Page 999 of the Public Records (collectively, the "Declaration of Condominium"), pursuant to the terms and provisions of the Certificate and Plan of Termination of the Declaration of Condominium for Grand Panama Beach Resort Office Condominium, which was recorded on June 30, 2015, at Official Records Book 3711, Page 1587 of the Public Records (the "Termination Plan").

- 1. <u>Articles of Dissolution; Effective Date</u>. The Association shall file with the Department of State of the State of Florida articles of dissolution in accordance with Section 617.1403, Florida Statutes. This Plan shall be effective as of the time the articles of dissolution are filed (the "Effective Date").
- 2. <u>Cessation of Business Activities</u>. In connection with the Termination Plan, the Association ceased conducting its affairs except to the extent appropriate to wind up and liquidate its affairs, including, but not limited to, (a) collecting its assets; (b) discharging or making provision for discharging its liabilities; (c) distributing its remaining property in accordance with the Termination Plan; and (d) doing every other act necessary to wind up and liquidate its affairs.
- 3. Plan of Distribution. The Association, in its capacity as the Termination Trustee under the Termination Plan, has (a) paid, discharged, or otherwise made adequate provision for all known debts and liabilities of the Association; and (b) distributed all Condominium Property, Association Property, Common Surplus, and other assets of the Association to Corr Properties I, LLC, a Florida limited liability company ("Corr"), which is the sole member of the Association. To the extent there is any remaining property, the Association shall distribute such property to Corr. Capitalized terms used in this Section 3 without definition in this Plan shall have the meanings ascribed to them in the Declaration of Condominium.
- 4. <u>Distribution of Assets Under Section 617.1406, Florida Statutes</u>. It is intended that this Plan shall be a plan providing for the distribution of the Association's assets under Section 617.1406, Florida Statutes.

5. <u>Authorization</u>. Each of the officers of the Association is hereby authorized, directed, and empowered without further action by the Association's Board of Directors or sole member, to execute and deliver any and all further certificates, instruments, and documents, and to take any and all actions, in the name and on behalf of the Association, as such officer, in his or her sole discretion, may deem necessary, desirable, advisable, or appropriate to consummate, effectuate, carry out, or further the distribution of the assets of the Association in accordance with this Plan and to do every other act necessary to wind up and liquidate the affairs of the Association, the execution and delivery of any such certificate, instrument, or document or the taking of any such action to constitute conclusive evidence that the same is authorized hereby.
