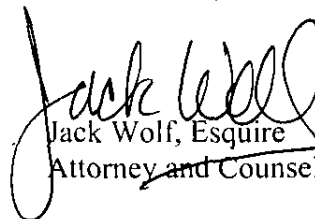

**Articles of Incorporation**  
**THE SOCIETY PLAYERS, INC.**

These Articles of Incorporation are prepared pursuant to and in compliance with Florida Statutes, Chapter 617 (Not for Profit) for the corporation *The Society Players, Inc.*. The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the non-Profit Corporation Law of Florida, do hereby certify:

**ARTICLE I**                      **NAME**

The name of the corporation shall be: The Society Players, Inc.

**ARTICLE II**                      **PRINCIPAL OFFICE:**

The principal place of business and mailing address of this corporation shall be: city of Lakeland, Florida –

3730 Myrtle Hill Way  
Lakeland, Florida 33811

**ARTICLE III**                      **PURPOSE:**

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE IV**                      **MANNER OF ELECTION**

Trustees, directors and officers are charged with the fiduciary duty to act for and in the best interests of the corporation. Election of trustees, directors or officers shall be accomplished by majority vote of existing stockholders, trustees or other officers during the annual meeting of the corporation. All officers shall serve for a period of two years, unless removed for cause or upon voluntary resignation of the officer. There shall be no less than two trustees, directors or officers of the corporation. Terms for officers shall be staggered; the term of the initial directors being for two and three years respectively, with all terms expiring at the annual meeting next ensuing. If the directors have staggered terms, then any increase or decrease in the number of directors shall be so apportioned among the classes of directors or officers as to make all classes as nearly equal in number as possible. Under no circumstances shall there be less than two trustees, directors or officers of the corporation.

Corporate officers shall occupy a quasi-fiduciary relation to the corporation and its stockholders. They are required to act in the utmost good faith, and in accepting the

office they impliedly undertake to give to the enterprise the benefit of their best care and judgment, and to exercise the powers conferred solely in the interest of the corporation.

**ARTICLE V            INITIAL TRUSTEES**

**ARTICLE VIII            EARNINGS:**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the

corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE IX      DISSOLUTION:**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

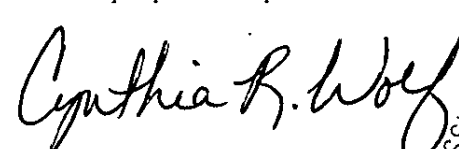
