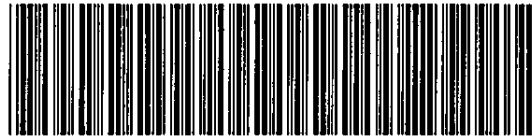

# Articles of Incorporation of South Brevard Mothers of Multiples

## Article VIII    Dissolution

### **Section 1.    Liabilities**

In the event of Dissolution of this organization, the Board of Directors shall make provisions for payment of all liabilities.

### **Section 2.    Distribution of Assets**

Distribution of the Clubs remaining assets shall be made to an organization qualifying as a Mothers of Multiples Club, which shall be organized, operated for charitable, educational and scientific purposes. No part of the net income or assets of the Club shall ever inure to the benefit of any director, officer or member or benefit of any private individual. Upon dissolution the outgoing Board of Directors shall select and vote on the receiving Multiples organization.
