No part of the net earnings of the Corporation shall inure to the benefit of, or distributable to its officers or private persons. "Notwithstanding any other provision of these articles, this corporation shall not except to an insubstantial degree, engage in any activities or excersice any powers that are not in furtherance of the purpose of this corporation".
Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code.
