ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

Friends of Matt Organization, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

Friends of Matt Organization, Inc. is organized exclusively for charitable, and any lawful purpose or purposes not for pecuniary profit and not specifically prohibited to corporations under other laws of this state. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed by a Court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

The affairs of the Corporation shall be managed by a Board of Directors, consisting of the President and Vice-President of the Corporation and such other Directors as provided for in these Articles, the By-Laws or the Declaration. The Corporation shall also elect a Secretary and a Treasurer.
