ARTICLES OF INCORPORATION Of SEASIDE SEVEN

SEASIDE SEVEN HOMEOWNERS ASSOCIATION, INC.

(A Florida corporation not for profit)



The undersigned, being all of the owners of Townhomes known as Seaside Seven, Jacksonville Beach, Florida, by these Articles, do hereby form a corporation not for profit under Chapter 617, Florida Statutes, and certify as follows:

ARTICLE I - NAME

ARTICLE II - DEFINITION

All words, phrases, names and terms used in these Articles of Incorporation, the Bylaws and the Declaration of the Association shall have the same meaning and be used and defined the same as they are in the Declaration of Covenants and Restrictions of Seaside Seven Townhomes.

ARTTCLE III - PURPOSE

The purposes of the Association shall be as follows:

- 3.1 To provide for the maintenance, preservation and architectural control of Building and Lots.
- 3.2 To exercise all of the powers and privileges and to perform all of the duties and obligations of the Association set forth herein, in the Bylaws or the Declaration as the same may be amended from time to time.

ARTICLE IV - POWERS

The Association shall have the following powers:

4.1 To exercise all of the powers and privileges and to perform all of the duties and obligations of the Association as set forth in that certain Declaration of Covenants, Conditions and Restrictions, hereinafter called the "Declaration" and applicable to the property,

or any portion thereof, and recorded or to be recorded in the Public Records of Duval County, Florida, as the same may be amended from time to time as therein provided;

- 4.2 To fix, levy, collect and enforce payment by any lawful means, all charges or assessments pursuant to the terms of the Declaration; to pay all expenses in connection therewith and all office and other expenses incident to the conduct of the business of the Association, including all licenses, taxes or governmental charges levied or imposed against the property or the Association; to borrow Money, and with the consent of five-sevenths (5/7) of the membership, mortgage, pledge or hypothecate any or all of its real or personal property as security for money borrowed or debts incurred;
- 4.3 To hold funds solely and exclusively for the benefit of the members of the Association for the purposes set forth in these Articles of Incorporation and the Declaration;
- 4.4 To promulgate and enforce rules, regulations, bylaws, covenants, restrictions and agreements to effectuate the purposes for which the Association is organized;
- 4.5 To delegate five of seven votes, the power or powers where such is deemed in the interest of the Association;
- 4.6 To purchase, lease, hold, sell, mortgage or otherwise acquire or dispose of, real or personal property; to enter into, make, perform or carry out contracts of every kind with any person, firm, corporation or association; to do any and all acts necessary or expedient for carrying on any and all of the activities and pursuing any and all of the objects and purposes set forth in the Articles of Incorporation and not forbidden by the laws of the State of Florida;
- 4.7 To charge recipients for services rendered by the Association where such is deemed appropriate by the Association by a five of seven vote of the Association;
- 4.8 To have and exercise by five of seven vote of the Association any and all powers, rights and privileges which a corporation organized under the Nonprofit Corporation Laws of the State of Florida by law may now or hereafter have or exercise;
- 4.9 Notwithstanding anything contained above to the contrary, no part of the net earnings of the Association shall inure to the benefit of any member and no distributions of income shall be made to its members, directors or officers.

ARTICLE V - MEMBERSHIP

Every person or entity who is a record owner of a Unit which is subject by covenants of record to assessment by the Association shall be a member of the Association; provided, however, there shall only be one vote allocated to each Unit. Any owner of more than one Unit shall be entitled to one (1) membership for each Unit owned by him or her. Membership shall be appurtenant to and may not be separated from ownership of any Unit which is subject to assessment by the Association. Change of membership in the Association for an Owner shall be established by recording in the Public Records of Duval County, Florida, a deed or other instrument establishing record title to a Unit in the Development and by delivery of a recorded copy of the same to the Association. The Owner designated by such deed thus becomes a member of the Association and the membership of the prior Owner is terminated.

ARTICLE VI - VOTING

The Members shall be all Owners of Units and shall be entitled to one (1) vote for each such Unit so owned. Notwithstanding any other provision in these Articles, the Declaration of Covenants and Restrictions, or the By Laws of Seaside Seven Homeowners Association, Inc., all matters which must be voted on require the approval of five of seven Owners.

ARTICLE VII - BOARD OF DIRECTORS OR DIRECTORS

- 7.1 The affairs of the Association shall be managed by a Board of Directors consisting of the number of Directors determined by the Bylaws, which shall be seven, with one person from each unit.
- 7.2 The names and addresses of the members of the Association who shall hold office until their successors are elected and have qualified, or until removed, are as follows:

with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent as provided for in Chapter 608, F.S.

ARTICLE X - INDEMNIFICATION

Every director and every officer of the Association shall be indemnified by the Association against all expenses and liabilities, including counsel fees, reasonably incurred by or imposed upon him in connection With any proceeding or settlement of any proceeding to which he may be a party or in which he may become involved by reason of his being or having been a director or officer of the Association, Whether or not he is a director or officer at the time such expenses are incurred, except when the director or officer is adjudged guilty of willful misfeasance or malfeasance in the performance of his duties; provided that in the event of a settlement the indemnification shall apply only when the Board of Directors approves such settlement and reimbursement as being for the best interest of the Association. The foregoing right of indemnification shall be in addition to and not exclusive of all other rights to which such director or officer may be entitled.

ARTTCLE XI - BYLAWS

The first Bylaws of the Association shall be adopted by the Board of Directors and as attached hereto and may be altered, amended or rescinded in the manner provided by the Bylaws.

ARTICLE XII - AMENDMENTS

Amendments to the Articles of Incorporation shall be proposed and adopted in the following manner.

- 12.1 Notice of the subject matter of a proposed amendment shall be included in the notice of any meeting at which a proposed amendment is considered.
- 12.2 A resolution for the adoption of a proposed amendment may be proposed by the members of the Association. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing such approval is delivered to the secretary at or prior to the meeting. Except as elsewhere provided:

- (a) Such approvals must be by not less than five-sevenths (5/7) of the votes of the entire membership of the Association.
- 12.3 Provided, however, that no amendment shall make any changes in the qualifications for membership nor the voting rights of members.
- 12.4 A copy of each amendment shall be certified by the Secretary of State and be recorded in the Public Records of Duval County, Florida.

ARTICLE XIII - TERM

The term of the Association shall be perpetual.
