# ARTICLES OF INCORPORATION OF <u>A & B CONDOMINIUM ASSOCIATION, INC.</u> <u>SECRETARY OF STATE</u> We, the undersigned, hereby associate ourselves together for the purpose of forming and

We, the undersigned, hereby associate ourselves together for the purpose of forming (a corporation not-for-profit under the laws of the State of Florida, pursuant to Florida Statutes Chapter 617, and hereby certify as follows:

# <u>ARTICLE I</u>

The name of this corporation shall be A & B CONDOMINIUM ASSOCIATION, INC., whose principal office is 80 Pinnacles Drive Suite 800, Palm Coast, Florida, 32164.

## <u>ARTICLE II</u>

The general purpose of this corporation not-for-profit shall be as follows:
