



**ARTICLES OF INCORPORATION
FOR

For the purpose of forming a not for profit corporation under Florida law, the incorporator hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of this corporation is ST. JOHN PRESBYTERIAN CHURCH LEARNING CENTER, INC.

ARTICLE II. PRINCIPAL OFFICE




