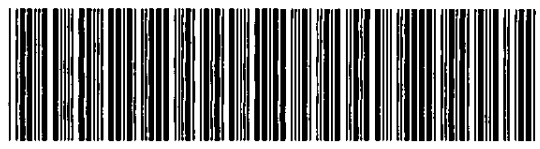

AMENDED ARTICLES OF INCORPORATION

OF

ST. JOHN PRESBYTERIAN CHURCH LEARNING CENTER, INC.

WHEREAS, ST. JOHNS PRESBYTERIAN CHURCH and JOHN CALVIN PRESBYTERIAN CHURCH are units of the PRESBYTERY OF TAMPA BAY, (hereinafter referred to as the "Presbytery"), a unit of the PRESBYTERIAN CHURCH (U.S.A.) (hereinafter referred to as "PCUSA"); and

WHEREAS, ST. JOHNS PRESBYTERIAN CHURCH and JOHN CALVIN PRESBYTERIAN CHURCH, PRESBYTERY, PCUSA, and any civil agencies related to them are exempt organizations under § 501(c)(3) of the Internal Revenue Code; and

WHEREAS, the Form of Government of PCUSA permits the separate incorporation of a corporation for the church to conduct mission operations, such as the operation of a school, as long as the corporation is a subsidiary corporation and is governed by the a member church of PCUSA; and

WHEREAS on July 20, 2007, ST. JOHN PRESBYTERIAN CHURCH LEARNING CENTER, INC. was formed as such a subsidiary corporation; and

WHEREAS ST. JOHN PRESBYTERIAN CHURCH LEARNING CENTER, INC. desires to make changes to its Articles of Incorporation.

NOW THEREFORE, pursuant to Chapter 617 of the Florida Statutes, the Articles of Incorporation of ST. JOHN PRESBYTERIAN CHURCH LEARNING CENTER, INC. are hereby amended as follows:

1. Articles I through V of the Articles of Incorporation are hereby deleted and replaced in their entirety by the following:

ARTICLE I - NAME

The name of this Corporation is **The Presbyterian Learning Centers of Tampa Bay, Inc.**

ARTICLE II - PURPOSES

The purposes for which the Corporation exists are as follows:

1. This organization is formed exclusively for charitable, educational, or literary purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding sections of any future federal tax code.

2. Notwithstanding any other provision of these Articles, this Corporation will not carry on any other activities not permitted to be carried on by (a) a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States internal revenue law) or (b) a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States internal revenue law).

3. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

4. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its Trustees, Officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.

5. To exercise any and all rights and powers conferred upon non-profit corporations by laws of the State of Florida as they now exist or as they may be amended.

ARTICLE III - DISTRIBUTION OF ASSETS UPON DISSOLUTION

Upon the dissolution of the Corporation, assets shall be distributed to St. John Presbyterian Church, Inc. or John Calvin Presbyterian Church of Tampa, Florida, Inc., or if they are not in existence, the Presbytery of Tampa Bay, Inc., or its successor in interest, each of which is a 501(c)(3) entity under the group exemption of the Presbyterian Church (U.S.A.) to be used for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE IV - TERM

The term of the Corporation shall be perpetual.

ARTICLE V - OFFICE AND AGENT

The registered office and principal office of the Corporation in the State of Florida will be located at 4110 N. MacDill Avenue, Tampa, FL 33607. The registered agent of the Corporation in the State of Florida at the registered office is Rev. Earl Smith.

ARTICLE VI - TRUSTEES

The management and disposition of the affairs and property of the Corporation shall be vested in Trustees, who shall be selected from time to time in such manner, with such terms, in such number and at such times as the By-Laws of this Corporation may provide. The number of such Trustees may be increased or decreased at any time by the By-Laws, but the number of Trustees shall never be less than ten (10). All the business of the Corporation shall be conducted by the Trustees under and subject to the direction of the laws of the State of Florida and of the United States of America. ARTICLE VII - OFFICERS


