ARTICLE I

Name. The name of this Corporation is THE MOST WORSHIPFUL GRAND LODGE OF FLORIDA, PRINCE HALL TRADITIONAL FREE & ACCEPTED ANCIENT MASONS, INC.

ARTICLE II

<u>Duration</u>. The period of duration of this Corporation shall be perpetual, commencing on the date of execution and acknowledgment of these articles.

ARTICLE III

<u>Purpose</u>. The purpose of this Corporation is to function as a statewide Masonic organization affiliated with other national and international Masonic organizations; to give primacy to the human and spiritual, rather than to the material, values of life; to promote a spirit of friendship and benevolence among its members; to assist the welfare of one another; to promote the adoption and application of higher social, business, and professional standards; to develop, by precept and example, a wise, discerning and serving citizenship; to promote a practical means to the formation of enduring friendship; to render altruistic services; to assist in the building of better communities; to cooperate in creating and maintaining that high idealism which makes possible the increase of rightcousness,

justice, patriotism and good will; and to provide an organizational structure for the various Masonic Lodges and organizations which comprise its members.

ARTICLE IV
