

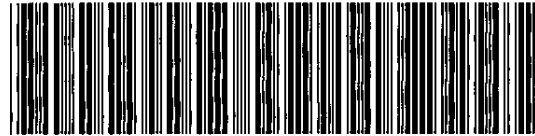



The undersigned hereby makes and subscribes to these Articles of Incorporation intending to form a corporation under the provisions of the Florida Statutes.

ARTICLE I

The name of this Corporation is FLORIDA SPORT TAEKWONDO ORGANIZATION, INC.

ARTICLE II

The specific purpose or purposes for which the organization is organized is to:

Provide full yearly tournament scholarships to qualified and deserving taekwondo athletes, their coaches and families in direct relation to and in preparation for the highest level of taekwondo competition, beginning at the local level, advancing to national qualifiers and eventually the Olympics. Taekwondo athletes will be required to submit an application, meet specific criteria ranging for skill levels or financial need in order to be eligible. Applications will be reviewed by the Board of Directors.

ARTICLE III

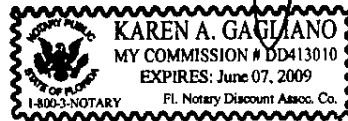


