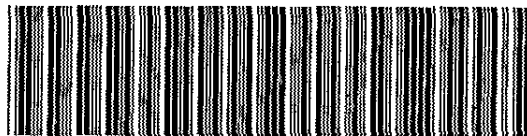

ARTICLES OF INCORPORATION

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation for Not For Profit under the Laws of the State of Florida.

ARTICLE I - NAME

The name of the Corporation is:

BEACON BAY FOUNDATION FOR THE BLIND, INC.

ARTICLE II - ADDRESS

The initial street address of the principal office of this Corporation is to be at 13355 Belcher Road South, Suite S Largo, Florida 33773. The initial Resident Agent shall GREGORY A. FOX, ESQUIRE, FOX & FOX, P.A., 28050 U.S. 19 N., Suite 100, Clearwater, Florida 33761.

ARTICLE III - PURPOSE

The purpose of this Corporation shall be to promote and advocate for the improvement of job skills for the visually impaired, including adaptive technology training, job training, job placement and develop computer software and hardware for the benefit of the visually impaired, and other such charitable actions as may be determined by the Board of Directors or members. The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law. Notwithstanding any other provision of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended.

ARTICLE IV - MEMBERSHIP

Any person who is interested in the development of this program shall be qualified for membership in this Corporation. Such person shall be admitted to membership upon his or her

application therefore and approval thereof by the Board of Directors of this Corporation.

ARTICLE V - EXISTENCE

This Corporation shall have perpetual existence, unless terminated by law, dissolution or unforeseen circumstances.

ARTICLE VII - OFFICERS

The business affairs of this Corporation shall be managed by the President, Executive-Vice President, Vice-Presidents, Secretary and Treasurer. The position of Secretary and Treasurer may be held by the same person.

ARTICLE VIII - INITIAL OFFICERS

The names of the officers who are to serve and manage all of the affairs of the Corporation until the first election or appointment under these Articles of Incorporation are:

ARTICLE IX - INITIAL DIRECTORS

The manner of election of the Board of Director are set forth in the Bylaws of the Corporation. The names and residences of the first Board of Directors who shall hold office until their successors are elected and qualified are as follows:

ARTICLE X - EFFECTIVE DATE

These Articles of Incorporation shall be effective upon receipt by the Secretary of State's office.

ARTICLE XI - AMENDMENTS

These Articles of Incorporation and the By-Laws of this Corporation may be made, altered or rescinded upon a two-thirds vote of the active members present at any regular meeting or special meeting of the membership duly called for that purpose.

ARTICLE XII - BY-LAWS

By-Laws shall be made, altered or Rescinded at a regular or special meeting of the members, by a vote of majority of a quorum of members present in person or by proxy.

ARTICLE XIII - PROHIBITED ACTIVITIES

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue

Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE XIV - DISSOLUTION

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

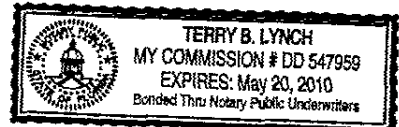

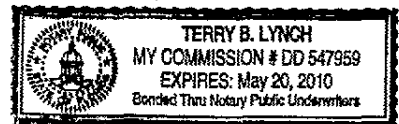
