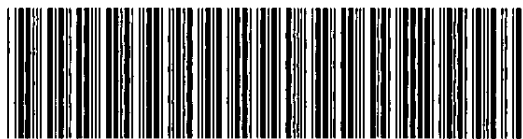

Pursuant to the provisions of Section 617.1006, Florida Statutes, the FLORIDA KEYS SCENIC CORRIDOR ALLIANCE, INC. adopts the following Amendment to the Articles of Incorporation of this Florida Not For Profit Corporation:

1.1. **Amendment Adopted:**

ARTICLE III - PURPOSES

3.1(g) Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code or shall be distributed to the federal government, or to a state or local government, for a public purpose.

1.2. **Date of Adoption and Effective Date.** The date of the adoption of the above stated amendment, and the effective date of said amendment, is November 13, 2007.

1.3. **Method of Adoption.** There are no members entitled to vote on this amendment. The amendment was adopted by a vote of the Board of Directors.
