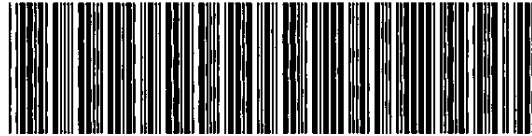

**ARTICLE I NAME**

The name of the corporation shall be:

**ARTICLE II PRINCIPAL OFFICE**

**ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

The general nature, purpose and objectives of this Organization are to: promote citizen awareness of the need for crime prevention; establish a coordinating council of all Neighborhood Watch programs in Tampa; work with the Tampa Police Department in the planning, development, promotion and execution of crime prevention programs for personal and property protection; and to foster effective communication and understanding between the residents of Tampa and their law enforcement officials to make all neighborhoods safer places in which to live.

**ARTICLE IV MANNER OF ELECTION**

The manner in which the directors are elected or appointed:

All officers of the Association shall be elected by a majority vote of the membership. The President shall appoint a nominating committee each year to present to the membership a slate of officers to fill expired terms. Election of officers will be held each year at the general membership meeting in March. Nominations of eligible and willing candidates may be accepted from the floor. To provide continuity, election for the office of President and Treasurer shall take place in even numbered years. Election for Vice President and Secretary shall occur in odd numbered years.
