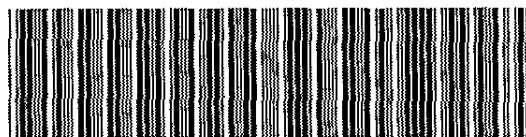

All of the foregoing purposes and powers shall be exercised exclusively for charitable and educational purposes in such manner that the Corporation shall qualify as an exempt organization under Section 501 ( c ) ( 3 ) of the Internal Revenue Code of 1954 as it is currently or hereinafter may be in force and effect.
