ARTICLE III

The Highland Pines Community Task Force, Inc., is formed exclusively for charitable and educational purposes, within the meaning of I.R.C.% 501 (c) (3). These purposes are to promote and advocate, through education, publicity, negotiation, and other lawful means, the establishment of a wholesome, clean, livable community environment (free of crime and drugs) for all citizens who reside in the Highland Pines Community. Whenever feasible, the Corporation shall work in cooperation and concertwith, and in support of established community groups and public and private agencies dedicated to the strengthening of this community's objective, and its membership shall reflect that goal.

The general purposes and powers are to have and to exercise all rights and powers conferred on not for profit corporations under the laws of Florida. All of the foregoing purposes and powers shall be exercised exclusively for charitable and educational purposes in such manner that the Corporation shall qualify as an exempt organization under Section 501 (c)(3) of the InternalRevenue Code of 1954 as it is currently or hereinafter may be in force and effect.

Directors are elected or appointed every two (2) years.
