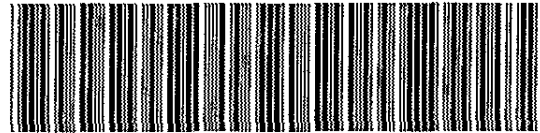

ARTICLES OF INCORPORATION

OF

FLORIDIANS ASSURING INSURED'S RIGHTS, INC.

The undersigned, for the purpose of forming a not' for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation is FLORIDIANS ASSURING INSURED'S RIGHTS, INC.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is 777 S. Harbour Island Blvd, Suite 765, Tampa, FL 33602.

ARTICLE III: PURPOSE

The Corporation shall be organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The purpose of the corporation is to provide a forum for the advocacy rights of policyholders to prompt, fair claims adjustment in order to achieve the benefits due under the coverages afforded by insurance companies.

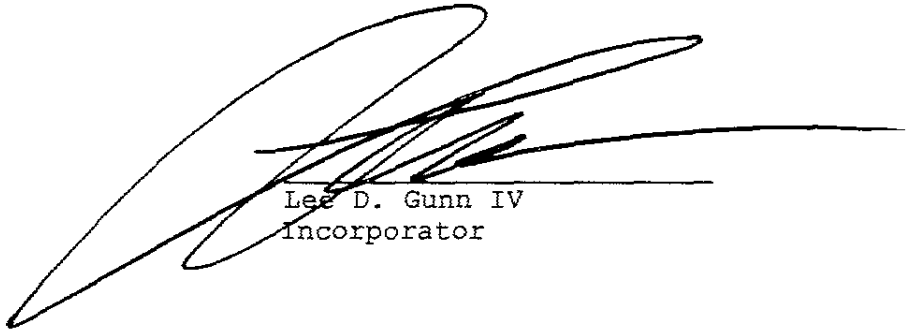
ARTICLE IX: AMENDMENTS
