**AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
CENTRO DE LA FAMILIA CRISTIANA DELTONA, INC.**

Pursuant to the provisions of Section 617.1001, Florida Statutes, this Florida Not For Profit Corporation adopts the following Articles of amendment to its articles of incorporation:

FIRST: Amendment adopted:

**Article III**

To add the following provisions as the first paragraph as follows;


A – This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501©(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

SECOND: The date of the above amendment's adoption shall be January 17, 2012.

THIRD: Adoption of the Amendment was approved by the Board of Directors unanimously on December 17, 2012. There are no members entitled to vote.


