# AMENDED AND RESTATED ARTICLES OF INCORPORATION BEACH HOMES FOR THE BRAVE, INC.

OF THE PROPERTY OF THE PARTY OF The undersigned hereby executes these Amended and Restated Articles of Incorporation for the purpose of amending the current Articles of Incorporation for Beach Homes for the Brave, Inc., a Florida not-for-profit corporation currently on file with the Florida Secretary of State office. The current Articles of Incorporation for Beach Homes for the Brave, Inc. are hereby amended and restated as follows:

### 1. DEFINITIONS

All terms used herein which are defined in the Articles of Incorporation for Beach Homes for the Brave, Inc. (the "Articles") shall have the same meaning as therein.

### 2. **NAME**

The name of the corporation shall be Beach Homes for the Brave, Inc., hereinafter referred to as the "Corporation" located at 8725 Placida Road, Suite 8, Cape Haze, FL 33946.

### 3. **PURPOSE**

The Corporation's exclusive purpose is to lessen the burden on the United States Government in providing assistance for Service men and women along with easing their stress in a post-war environment within the meaning of section 501-C3.

### 4. DISSOLUTION

Upon the dissolution of this Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501-C3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government or to a state or local government for a public purpose.

### 5. **ACTIVITIES**

The Corporation shall provide vacations free of charge to United States men and women and their families who have served during war time in Iraq and Afghanistan in Operations Iraqi Freedom and Enduring Freedom. The goal of the organization is to effectively perform our purpose to relieve the stress and fatigue of our service men and women and to assist the United States Government in providing assistance to these troops. The staff arrange for accommodations, restaurants, fishing trips, and other amenities for service members and their families which accounts for approximately 10% of the staff's total time. Vacations take place throughout the month based on the number of homes that are donated for occupancy. Currently, the program is for vacation properties on the southwest coast of Florida, but future plans are to expand the program to all vacation properties throughout the United States. Current activities are funded through donations to cover hard costs such as meals at restaurants, cleaning fees for the units as well as some other amenities that require a payment.
