ARTICLES OF INCORPORATION

OF

BROOK'S SUBDIVISION HOMEOWNER'S ASSOCIATION, INC. A FLODIDA CORPORATION, NOT FOR PROFIT

The undersigned incorporator(s) by these articles associate themselves for the purpose of forming a corporation not for profit under the laws of the State of Florida, and adopt the following articles of incorporation:

ARTICLE I. NAME AND ADDRESS

The name of the corporation is BROOK'S SUBDIVISION HOMEOWER'S ASSOCIATION, INC. For convenience, the corporation shall be referred to in this instrument as the "association", the articles of incorporation as the "articles", and the bylaws of the association as the "bylaws".
