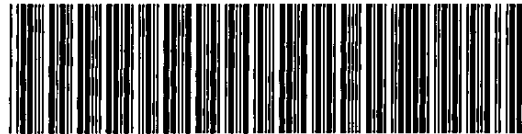

ARTICLE I NAME

The name of the corporation shall be: **Frank Lynch 2008, Inc.**

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:  
106 Pineview Rd., Jupiter, Fl. 33469-3114

ARTICLE III PURPOSE

The purpose for which the corporation is organized is to serve as a non-profit corporation as the authorized "**Principal Campaign Committee**" as defined by the Federal Election Commission, for the candidacy of R. Frank Lynch for President of the United States of America in the 2008 Primary and General Election, subject to the rules and regulations of the Federal Election Commission, and Title 11 CFR, and Section 572 of the IRS code, non-profit Political Organization. This corporation shall continue in existence until dissolved by a majority resolution of the Directors.

ARTICLE IV MANNER OF ELECTION

The original Directors are appointed by the incorporator: R. Frank Lynch. Immediately afterwards, the original officers are elected by a majority vote of the original Directors. Thereafter, the Directors and Officers each shall be elected, or removed from office by a majority vote of the Directors, with or without cause, in the sole discretion of the Directors. There shall be at least three and not more than five Directors at any time.
