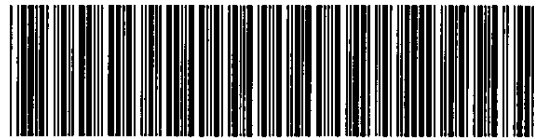

ARTICLES OF INCORPORATION FOR EXCALIBUR SAILING ADVENTURES

The undersigned is for the purpose of forming a nonprofit under Chapter 617 of the Florida Statutes hereby forms a corporation not formed for pecuniary profit and adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the Corporation is: EXCALIBUR SAILING ADVENTURES, INC.

ARTICLE II PRINCIPAL OFFICE

The initial principal office is: 73800 Overseas Hwy, Islamorada, Florida 33036.
The mailing address is: P.O. Box 1405, Islamorada, Florida, 33036.

ARTICLE III PURPOSES

This corporation is organized exclusively for charitable, religious, educational, literary and scientific purposes, including for such purpose, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code 1986 (as such Section or corresponding Section of any future federal tax law, may be amended from time to time). The specific purposes for which this corporation is organized are:

- (A). to promote sailing and associated outdoor activities as an aid to the mental and physical development of youth and young adults.
- (B). to provide access to sailing and associated activities to financially needy youth and young adults.

This corporation shall be authorized to exercise its powers permitted non profit corporations under chapter 617 of the Florida Statutes; provided, however, that the corporation, in exercising any one or more of such powers, shall do so in furtherance of the exempt purposes for which it has been organized within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the

corporation shall be authorized and empowered to pay reasonable compensation for services rendered and make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene (including the publishing or distribution of statements) any political campaign or behalf of or in opposition to any candidate for public office.

ARTICLE IV MANNER OF ELECTION

The qualifications for directors and the manner of their election shall be regulated by the by-laws.
