ARTICLES OF INCORPORATION FOR EXCALIBUR SAILING ADVENTURES

The undersigned is for the purpose of forming a nonprofit under Chapter 617 of the Florida Statutes hereby forms a corporation not formed for pecuniary profit and adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the Corporation is:

EXCALIBUR SAILING ADVENTURES, INC

ARTICLE II PRINCIPAL OFFICE

The initial principal office is: The mailing address is: 73800 Overseas Hwy, Islamorada, Florida 33036. P.O. Box 1405, Islamorada, Florida, 33036.

ARTICLE III PURPOSES

This corporation is organized exclusively for charitable, religious, educational, literary and scientific purposes, including for such purpose, the making of distributions to organizations that qualify as exempt organizations under Section 501©3 of the Internal Revenue Code 1986 (as such Section or corresponding Section of any future federal tax law, may be amended from time to time). No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene (including the publishing or distribution of statements) any political campaign or behalf of or in opposition to any candidate for public office.
