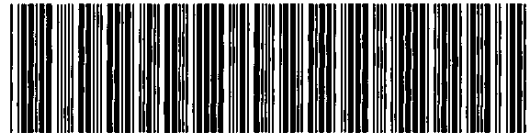

**ARTICLE I: NAME**

The name of the corporation shall be: **Deborah L. Natansohn Foundation, Inc.**

**ARTICLE II: PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be: **11113  
Lamplighter Lane, Potomac, MD 20854.**

**ARTICLE III: PURPOSE**

The purpose of the non-profit corporation is to honor the memory of Deborah L. Natansohn by promoting efforts to further the advancement of women in business through mentoring programs, educational partnerships, scholarships, and community outreach opportunities. Where possible, the Foundation's efforts will promote careers for women in travel and journalism. Among the charitable activities planned are:

1. Funding scholarships for the leadership development of educators in Florida through the Council for Educational Change, and other measures aimed at improving the quality of schools and/or expanding the horizons of underprivileged students.
2. Funding scholarships at the Florida International University's School of Tourism and Hotel Management.



3. Promoting executive mentoring programs for women by promoting scholarships for female executives of non-profit corporations to attend mentoring programs at The Commonwealth Institute of South Florida.

This corporation is organized exclusively for charitable, cultural and educational purposes, including, for such purposes the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **ARTICLE IV: ELECTION OF DIRECTORS**

The manner in which the directors are elected or appointed will be appointed according to the Bylaws of the corporation.

**ARTICLE VII:**

This Corporation is organized and operated exclusively for charitable purposes within the meaning of Section 501(c)(3), Internal Revenue Code.

**ARTICLE VIII:**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE IX:**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in

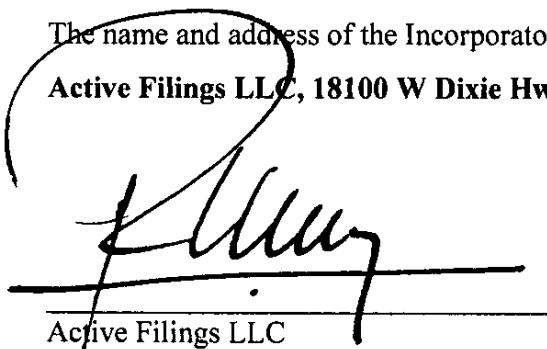

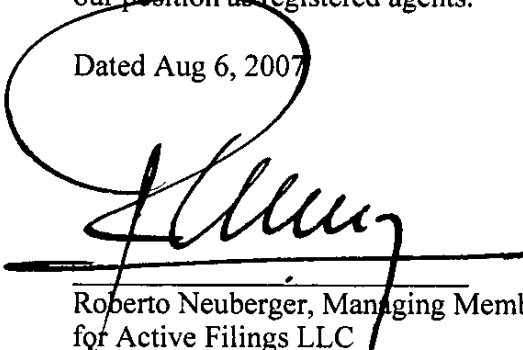
