ARTICLES OF INCORPORATION
OF
BUILDING BETTER LIVES FOR PEOPLE, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopts the following Articles of Incorporation, pursuant to Chapter 617.0202, F.S.:

ARTICLE I.

The name of this corporation shall be:
BUILDING BETTER LIVES FOR PEOPLE, INC.

ARTICLE II.

The corporation may engage in any or all lawful business permitted under the laws of the State of Florida.

ARTICLE III.

Said Corporation is organized exclusively for charitable and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, the corresponding section of any future federal tax code, or charitable organizations operated around the world in pursue of educational needs for children.

ARTICLE IV.

The street address of the corporation's initial registered office and principal place of business shall be 7461 Northwest 4th Street, Plantation, Florida 33317-2216.

The name of the corporation's initial incorporator at this address shall be Anne L. Reinstein. The principal place of business is 7461 Northwest 4th Street, Plantation, Florida 33317-2216.

ARTICLE V.

The initial officers/directors of the corporation are:

President/Director - Anne L. Reinstein
Secretary/Director - Rocio P. Claros
Treasurer/Director - Andrea Geldres-Cocks

ARTICLE VI.

Initially, the officers/directors will be appointed by the direction of the incorporator; thereafter, according to the By-Laws. The Corporation shall have not less than three (3) directors.

ARTICLE VII.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VIII.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
