



Article I

The name of the corporation shall be Junior Bulldogs, Inc.

Article II

The principal place of business and mailing address of this corporation is to be located at: 4502 Dolphin Drive, Tampa, Florida 33617 in, Hillsborough County, State of Florida and may transact its business and maintain offices for such purposes at such other places either within or without the State.

Article III

Said corporation is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations under Section 501(c)(3) of the Internal Revenue Code (or the corresponding section of any future Federal tax code).

The corporation will conduct non-profit charitable educational and scientific activities and seminars in the state of Florida and throughout the United States of America. This corporation is designed to develop and coordinate programs with sensitivity to the needs of youth ages 13-17. Our programs will include but not be limited to health and recreational activities, sports leagues, educational services, and outreach.
